Robert has had to step down because of health reasons from his position as Finance Chair. Past President Wayne Lowry has agreed to take on the finance chair, thank you Wayne! Wayne's past experience as finance chair will be welcomed with open arms!

Also moving on is our Executive VP, Martin Sharren, who has informed the AFGA executive that as of February 26, 2020 he will be retiring. Martin has been with AFGA for many years now and his wealth of knowledge will be greatly missed along with his warm and pleasant personality. Martin has agreed to help with the hiring of the new Executive Director position. As I write this article, AFGA is in the process of searching for a suitable candidate. Your senior executive also met in Edmonton to go over the EVP job description, as well as discuss the direction we need to take in the coming months.

In June the senior executive met with Alberta Environment and Parks to go over a number of issues. Firstly, all resolutions that were passed by a minimum vote of 75% as well as AFGA position statements which were also forwarded on to Honourable Jason Nixon, including copies to Travis Ripley Executive Director, Fish & Wildlife Policy, Alberta Environment and Parks.


In mid-June, Andrea and I as well as Doug and Robyn Butler went to Halifax where Doug and I attended the Canadian Wildlife Federation conference. Andrea and I arrived in

Halifax on the Monday prior to the conference giving us a few days to explore this wonderful area! If you ever get the opportunity to travel to this area I would highly recommend going! I do have to admit I much prefer our 5% GST tax over what they have to pay there. Saturday, we attended the Federation banquet. It gives me great pride to congratulate Duane Radford who was awarded the Roderick Haig-Brown Award. Congratulations Duane from all of us at AFGA!

On Thursday, June 20th I received a call from the Minister's office asking if we could meet Monday at 4:00 pm, giving us a one hour time slot, with the only other option being that if an opening came up possibly in August or in early fall. As you all know AFGA has requested to meet with the minister several times. Feeling that AFGA needed to take advantage of this opportunity, I accepted. Unfortunately, Past President Doug Butler, Finance Chair and Past President Wayne Lowry were not available as well as 2nd Vice President Matt Zazula, because of previous commitments. The meeting went very well, by my thoughts. Ian had prepared a list of priorities which were discussed.

We first addressed that it appears that a number of smaller interest groups have been given priority over AFGA when being asked to the table

regarding consultation. We expressed AFGA is the oldest and largest conservation association in Alberta, being the voice of hunters & anglers in Alberta! Minister Nixon was very receptive to our concerns! Travis from AEP was present to answer questions relating to his office, the turkey, bear, and a few other management plans that have been sitting on his desk for some time waiting for the minister to sign off on them. We asked for an extension to the minister's special license raffle which hopefully will happen. Sale of public land and leased land access were discussed, as well as the fee for access to public lands. Over the years numerous resolutions have gone forward to the minister with little to no response. We are asking Minister Nixon that in future we would like honest answers, whether it be yes or no. Again hopefully that will happen! We touched on the Métis harvest agreement and feral horses. Darryl spoke on a number of fisheries issues which I am sure he will be providing an in depth report to all in the near future on those items.

Minister Nixon was very receptive to future meetings with AFGA which I will be sure to contact all executive to try to attend. Being the amount of time we had with the minister I feel we covered a lot of ground.

Planning is also underway for our next AGM and Sherwood Park is hosting this conference.

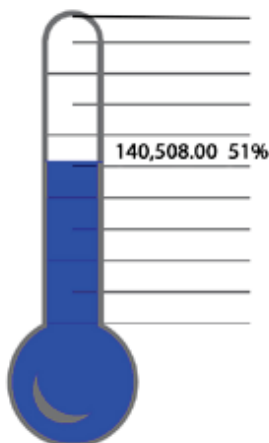
I still have some walleye tags to fill and am awaiting the hunting draw results right now. Wishing you all a great fall season and success in the field.

**THE CONFERENCE ON CHRONIC WASTING DISEASE:** Word comes from Past President and Life Member Rod Dyck, who attended a Conference on Chronic Wasting Disease on behalf of AFGA in March of this year, that there were some highly interesting presentations and he recommends reading and viewing all of them especially those dealing with Alberta and Saskatchewan. There was also a panel discussion which provided information from the game ranching perspective.

The Conference featured top experts from natural resource management, ecology, molecular biology, human health, epidemiology, wildlife policy, psychology, sociology, economics, Indigenous perspectives, and veterinary medicine to help establish the need for an integrated approach to addressing the threats posed by CWD. In all, over 50 organizations were represented at the event.

**2020 CONFERENCE:** The 91st Annual Conference and General Meeting being co-hosted by Sherwood Park Fish and Game Association will be held February 20-22, 2020 at the Clarion Hotel in Sherwood Park. Conference Chair Steve Witiuk has assembled a great group of people to be on the organizing committee and looks forward to planning an outstanding event.

Currently two openings exist for a Companion Coordinator and a Youth Coordinator so if you or someone you know is interested please contact myself or Sandie Buwalda at the office for more details. Maybe you and a friend might want to share a position; that would be more than acceptable.

**SPECIAL HUNTING DAYS:** September features several special days recognizing and promoting the Alberta traditions of hunting and conservation of our wildlife resources. The first of these are:


Waterfowler Heritage Days - First Saturday And Sunday In September

Eligible youth can hunt migratory game birds on these two days without a Migratory Game Bird Hunting Permit or a provincial Game Bird Licence. Water fowler Heritage Days occurs throughout Alberta (in all WMUs where there is, or will be, an open migratory game bird hunting season). Youth can hunt migratory game birds for which there is or will be an open season in that WMU. Regular bag limits apply. See the Alberta Guide to Hunting Regulations for bag limits for each species.

Youth are defined as being 12-17 years of age that have passed the Hunter Education course. They must also be accompanied by an adult who is in possession of a Migratory Game Bird Hunting Permit. Next on the list is:

Provincial Hunting Day - Fourth Saturday in September  
AFGA played a major role in the establishment of this day which the Government of Alberta has designated as Provincial Hunting Day.

Aside from the opportunities for eligible youth to hunt upland game birds, hunting groups will be hosting events throughout Alberta and will be providing mentoring opportunities for first-time hunters. Check out the Alberta Hunter Education Instructors Association (AHEIA) for a list of their events, as well as other organizations. Also if you or your Club is involved in a special event please let me know and we can put it on the Provincial calendar.

In any event I encourage you to participate in any/all of these days and take a young person along!

# 1st Vice-President's Report

FALL WILL BE here, or nearly so when this reaches you, and I sincerely hope you were able to enjoy some quality time in our great outdoors over the summer and will continue to do so through the fall.

Your AFGA executive had reached out to the new Minister of Environment and Parks immediately after the Provincial election, but we had not received a response to our requests to meet with him. Following up with his constituency office (which is not far from where I live) revealed that our request had got lost in the transition and staff turnover, and that the Minister was in fact eager to meet with us, which Brian Dingreville, Darryl Smith and myself did on very short notice. While we only had one hour of the Minister's time and did not have all of the senior executive and key chairs present due to the short notice, I think it was very worthwhile to go ahead in somewhat of a rush without all of the key AFGA chairs present. The

alternative was waiting until fall, as the Minister's staff couldn't commit to any other space on his schedule. We have asked for a follow up meeting which hopefully can be both better planned and somewhat longer.

The meeting started out on a positive note, with Minister Nixon asking for the opportunity to address the 2020 AFGA conference just after introductions, a very pleasant change from our invitations to the previous Minister going unanswered a couple of times. It was also positive to be able to skip over an explanation of who and what AFGA is; Minister Nixon already knows, and while AFGA must remain apolitical, it's a very long time and several Ministers ago since that has been the case!

Since we only had one hour of his time scheduled, we focused on high priority items such as recognizing the value of public lands, habitat, and fish and wildlife, access to public lands and wildland parks, re-establishment of a Government department focused on such issues reporting through the same Ministry, access and the sad state of Alberta's fisheries management which Darryl provided extensive documentation on. We just touched briefly on many other issues such as caribou recovery, predation, grizzly bears, feral horses and others, and the difficulty the Government faces when confronted with situations where emotion gets in the way of facts. Minister Nixon conveyed a good understanding of the need for balanced management and a step by step approach to getting back there, and we stressed AFGA's desire to work with the Minister's staff on possible solutions.

At the Federal level, it appears from news reports that Minister of Public Safety Bill Blair listened to at least some of what AFGA and others had to say regarding the idea of "A complete ban on handguns and assault rifles"(see my

report in May/June Outdoor Canada West) and that idea is on hold for now, but the debate is far from over and it will almost certainly be an issue in the upcoming federal election campaign that will be in full swing when this reaches you.

Closer to home, Chronic Wasting Disease testing from the 2018/19 hunting seasons in Alberta has now been posted here <https://www.alberta.ca/chronic-wasting-disease-updates.aspx> and as expected, it continues to expand. This issue is finally starting to get national and international attention; more information can be found here: <https://www.ofah.org/ccac/>. Recognizing the potential seriousness of the problem is one thing, reaching a consensus on what to do about it is much more difficult. Unfortunately, even within the hunting community, short term selfish concerns about the impact of proposed CWD management strategies on "my backyard deer herd/ my business/my hunting strategy/ et cetera" derailed any meaningful attempts to minimize its spread in the past. Now what?

Fall zone meetings will be imminent when this is in your hands and once again, please get any resolutions through your club and to the Zone directors as soon as possible. The procedure is outlined in my report in the July/August Outdoor Canada West, and in the AFGA Operations Manual which can be found on our web site. Resolutions have to be passed at the Club and Zone level before coming to the December full Executive meeting, and I will gladly help anyone with the wording and through that process. 🐦

Sitting here in June writing this, I am full of wonder what my family and I have drawn and as soon as the results are out, the planning process of the logistics of each person's hunts will begin. It is definitely part of the whole experience. I know I am looking forward to seeing if our daughter Miyah was successful in finally pulling a tag after several years of building up priority for bucks and bulls. Lately I have been more excited to see her be successful in her outdoor pursuits than I am concerned about myself. Have you taken a youth hunting? Have

know a full 25% of people who apply in the draws do not even hunt that year? This is adding to everyone's wait time and number of years priority to draw tags. We will see if the projected outcome of lowering draw wait times drop and our revenue gained from purchasing the Wildlife Certificates go up which can help to offset the loss of some funding when the lower priced senior tags were announced under the previous government.

Finally, don't forget to sight in your rifles and practice with your shotguns before heading afield. Now is the time to ensure all your gear is in good working order and everything is clean and ready. Check all your boots too as I had to replace shoelaces after the first day out last year. A little proactive preparation goes a long way to ensuring your success afield!

# Fishing Chair Report

## ARE WE COLLECTIVELY ON A NEW PATH?

I pondered in mid-June what would be the subject matter of this column? The Senior Executive and Hunting Chair of the Alberta Fish and Game Association (AFGA) had met with Travis Ripley, Executive Director of Policy Division Fish and Wildlife and his team in late May. Unfortunately, at the last second I could not attend. Those there did address topics that had been put on the agenda related to fisheries. The topics could be summarized as updates and reintroduction of themes the AFGA had been pursuing that possibly might gain some traction under the new government's leadership.

This was still a time when the bureaucracy was adjusting to the reality of the change at the political level. For example, an email from John Conrad, Assistant Deputy Minister of Operations Division on May 14, 2019 to the Fisheries Stakeholder Advisory Committee tasked with the third-party science review of fisheries management in Alberta stated:

"Thank you for your patience during this period while we form our new government. I am actively sharing information with our executive, including the work underway with

the Fisheries Stakeholder Advisory Committee, and the opportunity this committee provides. Please continue to stand by and I will keep you apprised as more details are available."

After the meeting, was able to have further discussions with Dave Park, Director, Fisheries Management Policy. The tone and topics gave me hope that perhaps a resetting of relationships, agenda, and charting a different path forward related to fisheries management in Alberta was possible!

On very short notice, the AFGA was invited to meet with the Minister of Environment and Parks, Jason Nixon on June 24, 2019. The topics put forward were the key issues from the AFGA perspective including fisheries. The dialogue was two-way. For the first time in recent memory, we felt the concerns of the AFGA were being taken seriously. Perhaps it is because we now have a minister who is an outdoorsman, hunter and fisherman. Regardless of who is in this role, it must be about environmental stewardship which at the same time addresses economic and social consequences plus transparently discloses tradeoffs. I expect other members of the AFGA Executive who were in attendance will discuss the

meeting as well in their columns.

From a fisheries perspective, the AFGA direction is born from discussions with members, zones, executive, resolutions, position statements, policy and the document introduced at the February 2018 Annual General Meeting, Redefining Fisheries Management in Alberta "Call for change from the Alberta Fish and Game Association" <https://www.afga.org/redefining-fisheries-management-in-alberta/>. Our position is not static as it is constantly evolving as new information comes to the table. We did leave the Minister with the following:

There are seven key elements that require fundamental change, rethinking, or refocus within the Government of Alberta as it relates to angling, fish, and habitat:

1. Coldwater fish species management (Trout, Char, Arctic Grayling and Mountain Whitefish)
2. Coolwater fish species management (Walleye, Northern Pike, Yellow Perch, Lake Whitefish)
3. Operation Branch/Policy Branch/ Departmental/Inter Ministerial disconnects including lack of transparency
4. Communication narrative and lack of meaningful consultation
5. Methodology, benchmarks, metrics and models as they relate to Species at Risk Act (SARA), Fish Sustainability Index (FSI) and management frameworks
6. Sportfishing Regulation simplification versus standardization
7. Failure to utilize a wide range of tools to manage our fisheries resource and required habitat

At the same time the AFGA was also invited to present to a United Conservative Caucus Committee chaired by UCP Caucus Chair Todd Loewen that is advising the minister. This meeting took place on July 3, 2019. Presenting at the same time was Ray

Makowecki on behalf of the Next Step Team. Both presentations had synergy with numerous common themes. Questions from the committee members show knowledge of the issues and desire to chart a different course. Whether and what will translate down from the political level to the bureaucracy is an unknown?

The AFGA during the committee meeting reinforced key points related to the direction we believe that fisheries management must head:

- Protecting, enhancing and restoring habitat is the critical issue in ensuring the long-term sustainability of fisheries
- Habitat protection, enhancement, and restoration which is considered secondary to monitoring, research and regulating anglers must come to the forefront
- Linear access management is a key element in any integrated land-use plan as it linked to habitat, illegal activity and angling pressure concerns
- Policy and plans must extend to both private and public lands with focus on environmental stewardship
- Environmental education, communication and awareness must be part of any ongoing plan
- Heightened enforcement and compliance monitoring of not only anglers, but of other users on the landscape including industry
- Angling Education and adoption of citizen science

- Use all the tools available including fish stocking, predator management, invasive aquatic species control and habitat creation
- Current Fishery Zones would be realigned and renamed based on habitat and species composition
- New angling regulations with emphasis on simplified conservation-based approach with sustainable harvest objective
- Creating angling opportunity offsets as a result of more restrictive angling regulation paradigm must become a major priority for managers
- Management of species at risk (Athabasca Rainbow Trout, Westslope Cutthroat Trout, Bull Trout and Arctic Grayling) to focus on overall ecosystem not species
- Enhanced Fisheries Stamp or Coldwater Fish Stamp as part of sportfishing licence
- Robust fish stocking program with emphasis on Walleye, salmonids, and other fish species for both restorative stocking and put and take opportunity
- Dedicated Fish and Wildlife Ministry or Fish and Wildlife Commission
- Risk metrics must not be confused with health and status of a fish population
- Fisheries management must focus on the ecosystem, not single species metrics

I left both meetings invigorated! Possibly a new era where politicians, bureaucrats, fisheries managers, anglers,

and stakeholders can be on the same page, talking about the positives, not the negatives, in a spirit of mutual respect is on the horizon.

This culminated in a bit of a road trip. I managed to drop into Lacombe to see the new “Guinness World Record” for the largest fishing lure, the iconic “Five of Diamonds” located at the Lacombe Fish and Game Club Len Thompson Trout Pond. While seeing the lure was the intention of the visit, exciting was to see the partnerships. Even more heartening was the fact that every dock around the pond was occupied by kids and families taking part in our heritage of angling which is a cornerstone. The fact that this was National Fishing Week gave renewed hope that angling will be embraced by Canadians in the coming decades! 🐟

# Environment Chair Report

HOW QUICKLY TWO months can pass! I wish to start by recognizing the Alberta AFGA Zones 1 through 5 in electing Zone Environmental Chairs. This will greatly facilitate spreading the “news”.

The recommendations of the Alberta Environmental Appeals Board in the case of the Phelan Pit on the Freeman River were submitted to the minister by the end of May, but the change in provincial government may delay the final decision in this case.

Your Alberta Fish and Game has submitted a Feral Horse Fact Sheet Request to the Alberta Invasive Species Council. This is the first step in a formal process to have feral horses defined as an invasive species.

The office of the Auditor General of Canada has issued an independent report on whether Fisheries and Oceans Canada and the Canada Border Services Agency implemented

adequate measures to prevent aquatic invasive species from becoming established in Canadian waters. Preventing introduction of new invasive species is very important, since elimination of that new invasive species is only really possible in the very early stages of discovery. After that, we are dealing only with preventing the spread and managing the impact. Overall, both departments have failed in this regard. A key component was a failure of Fisheries and Oceans Canada to distinguish its responsibilities from those of the provinces and territories. Not knowing who should do what and when prevents an aggressive response to initial invasion threats. Credit was only given to the action taken to address Asian carp species on the Great lakes.

Fisheries and Oceans Canada has prepared a Discussion Paper on harmonizing the Applications for Authorizations under the Fisheries Act with an amending Bill C-68 that passed the House of Commons in 2018. The changes proposed by the bill to improve oversight of development activities and the management of fish and fish habitat include:

- protection for all fish and fish habitats;
- restoring the previous prohibition against ‘harmful alteration, disruption or destruction of fish habitat’;
- restoring a prohibition against causing ‘the death of fish by means other than fishing’;
- new authorities to amend, suspend, or cancel authorizations;
- a new requirement to make information on project decisions public through an online registry. The full Discussion Paper and a link to Bill C-68 can be found here: <http://www.dfo-mpo.gc.ca/campaign-campagne/fisheries-act-loi-sur-les-peches/paper-document-eng.html>.

A concern has come to my attention with respect to a proposed commercial development for a full motorsports facility immediately adjacent to the Rosebud River in southern Alberta. More than half the proposed development falls in a High-2 classification for Environmentally Significant Areas. Stay tuned.

Finally, in response to those of you who asked the question: “Who is that aged garden gnome in the photograph with your report?” I include a cleaner, earlier version from a fishing trip on Brentwood Bay a few years ago. 🐦
